





AN ORDINANCE TO REPEAL AND RECREATE SECTION 1-19, Chapter 1, General Provisions  
ARTICLE II  
FEES AND PENALTIES

The Town Board of Supervisors of the Town of Ledgeview do hereby ordain as follows:

**Section 1:** Repeal and Recreate Section 1-19, Fee Schedule, Chapter 1, General Provisions of the Town of Ledgeview Municipal Code is hereby amended to read as follows:

~~At the time the application for a building permit is filed, the applicant shall pay the fees as set forth in the attached Exhibit 2, which exhibit is incorporated herein by this reference, and any other fees which may be specifically designated by state statute or Town ordinance.~~

All town fees are set forth on the fee schedule attached as exhibit two, which exhibit is incorporated herein by this reference, and including any other fees which may be specifically designated by state statute or town ordinance. All fee amounts listed on exhibit two supersede any other fees listed in the Town of Ledgeview Municipal Code.


This fee schedule may be amended by resolution of the Town of Ledgeview town board in accordance with the statutory authority provided in Chapter 66 of Wisconsin statutes.

**Section 2:** Repeal of inconsistent ordinances. All existing town ordinances, parts of ordinances, and amendments thereto in conflict with any of the provisions of this ordinance are hereby repealed.

**Section 3:** Severability. If any section, clause, provision or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remaining provision shall not be affected hereby.

**Section 4:** Effective date. This ordinance shall take effect upon passage, postage, and publication.


